

FACTS**WHAT DOES VELARA WEALTH MANAGEMENT INC. DO WITH CUSTOMER INFORMATION?****Why?**

Financial companies choose how they share your Customer Information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your Customer Information. Please read this notice carefully to understand what we do.

What?

The types of Customer Information we collect, and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and payment history
- Any data or analysis derived from this information

How?

All financial companies need to share Customer Information to run their everyday business. In the section below, we list the reasons financial companies can share Customer Information; the reasons we choose to share; and whether you can limit this sharing.

For our affiliates to market to you	Yes	Yes

Definitions			
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.		
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.		
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.
